

# Manischewitz Issues a Product Mislabeling Advisory and Voluntary Recall on some very limited units of their Dark Chocolate Coins

**Bayonne, NJ. (December 1st, 2023)** — **Manischewitz**, is recalling Manischewitz Dark Chocolate Coins. In some very rare instances; Inside Units (the "bag") within a Milk Chocolate Coin Display Box may be labeled as "Dark Chocolate" but contains Gold Foil coins within a Blue Netting, which *are dairy*. People who have an allergy or severe sensitivity to milk, run the risk of serious or life-threatening allergic reaction if they consume these products.

The Manischewitz Dark Chocolate Coins were distributed to stores nationwide, predominately located in the New York, New Jersey and Connecticut regions, during the weeks of September 26th, 2023 through November 28th, 2023.

This recall was initiated after the company was notified by their Quantity Control Department that a limited number of bags labeled as "Dark Chocolate Coins" contained Milk Chocolate Coins, which contains milk allergen that is not declared on the label. All dairy Milk Chocolate Coins are wrapped in Gold Foil within a Blue Netting and all non-dairy Dark Chocolate Coins are wrapped in Silver Foil within a Red Netting.


Only packages bearing the Lot Code below, may *potentially* have gold (dairy) coins in the "dark-chocolate tagged" bag. (Retailers take note the UPC in which you bought this product would be the following UPC 072700200356 which is the Milk Chocolate display Box)




## **Correct Labeled Milk Chocolate Coins**






## **Correct Labeled Dark Chocolate Coins**

Consumers may return the product for credit or refund. If a consumer experiences an allergic reaction they are urged to report to a medical provider.
